1. Place and date

4. Accommodations

5. Mexican Entry Requirements

All participants of the Regional Forum "Civil Society in the Process of Hemispheric Integration within the Framework of the Special Summit of the Americas" must have a valid passport, with the appropriate immigration document, to enter Mexico.

All delegates and participants should complete the necessary procedures sufficiently ahead of time at a diplomatic or consular mission of Mexico. A directory of such missions can be found on the Mexican Organizing Committee's Web page.

6. Transfer from airport to hotel

Delegates are advised to use only those transportation services (taxis) authorized by the Mexico City International Airport (MEX), which can be hired inside the airport, in the international area to the left as one leaves Customs, and in the domestic area near the baggage claim conveyor belts.

The Hotel Meliá Reforma is 30 kms from the airport and a taxi will cost 200 pesos (around US\$21).

7. Transfers for participants

Transfers between the Hotel Melía Reforma and the Conference Area of the Secretariat of Foreign Affairs will be provided at no charge to accredited participants. The schedule for this service will be announced later.

For transportation outside the established schedule, participants are advised to hire taxis from stands or request them at the hotel. They may be hired by telephone at any commercial or tourist establishment. The cost will be covered by the participants.

9. Working languages and documents

Forum proceedings will be conducted in Spanish and English. Simultaneous interpretation into these languages will also be provided.

10. Telecommunications

In Mexico, cellular telephone service is available using the TDMA (time division multiple access) and GSM (global system for mobile communications) technologies. In GSM, the communications frequency band is 1900 MHz. A list of international roaming agreements is available on the Web page: www.comormex.org/oea-seguridad.

11. General Information

a. Currency

The Mexican monetary unit is the peso (\$ or MXP). It is issued in banknotes of 20, 50, 100, 200, and 500 pesos, metal coins of 10, 20, and 50 centavos (cents), and metal coins of 1, 2, 5, 10, and 20 pesos.

The most commonly used credit cards are Visa, MasterCard, and American Express, which are accepted at most establishments. Automatic teller machines are available around the clock at banks and commercial centers.

On November 18, the exchange rate was 11.32 pesos per one United States dollar. Currency can be exchanged at banks and foreign exchange houses.

b. Weather

During the Conference, the temperature in Mexico City is expected to range between 10° and 21° C (50° and 70° F).

c. Voltage

The electric standard in Mexico is 110 volts, 60 hertz.

d. Local time

In November, the time in Mexico City is one hour earlier than in Washington, D.C.
